

San Mateo Creek-So Cal'<mark>s Gold Standard</mark>

an Onofre State Beach is a rare 3,000-acre scenic coastalcanyon park with high environmental values and recreation use. The park includes three distinct areas: San Onofre Bluffs, San Onofre Surf Beach, and San Mateo Campground. San Onofre - San Mateo Campground lies a short distance inland from the 3.5-miles of sandy beaches within San Onofre State Beach. A 1.5-mile Nature Trail connects the campground to Trestles Beach, a world class surfing site. San Mateo Creek flows just east of the campground outward towards the ocean creating key riparian and wetland habitats which host some rare and even endangered species. . Considered an environmental "hotspot" because of the health of the ecosystem, it is home to a number of rare, threatened or endangered species. Arroyo toad, cactus wren, California gnatcatcher, mountain lion, and the southern steelhead trout are

# SAVE TRESTLES CAMPAIGN WINS IN SAN DIEGO San Diego City Council **Votes To Support California**

State Parks...09/25/2007

The Surfrider Foundation's Save Trestles campaign won a major victory, as the San Diego City Council voted 6-2 to approve a resolution "supporting the examination and implementation of feasible alternative transportation projects, including improvements to Highway 5 that do not impact San Onofre State Beach, or other park lands, and beaches."

The Surfrider Foundation and its coalition partners maintain that a proposed extension to the SR-241 toll road will result in adverse impacts to a significant portion of San Onofre State Beach Park and the surrounding beach and water-

Group 1: Meet the group leader at 7:30 a.m. at the Indian Cove Ranger Station on Indian Cove Road. This is off Highway 62 on the western side of Twentynine Palms at the entry of the park leading to Indian Cove Camp Ground. After covering Indian Cove the group will go to parts of Twentynine Palms, the Oasis of Mara (the park headquarters), Luckie Park and the 29 Palms Inn.

Group 2: Meet the group leader at 7:30 a.m. at the West Entrance of the Park. Take Park Blvd. from the town of Joshua Tree, parking is just beyond the entry station. This group will cover the campgrounds in the interior of the park, Hidden, Lost Horse and Queen Valleys. This part of the park is 3,000-5,000 ft with an abundance of rocks and Joshua Trees. And we hope to see a bird or two.

The daily use fee for the park will be waived for the Christmas count participants. The Joshua Tree National Park Association will cover the count participant fees. We can't make it any easier than that! Bring layers of clothing, it can be cold and windy or it can be warm and calm, we've had everything from 78 deg. to snow blowing straight at you. Also bring snacks, good walking shoes, lunch and drinks, or you can pickup lunch in Twentynine Palms if you choose group 1. Group 2 will have to rough it, no phones, no restaurants, but just beautiful country. We will meet about 5:30 p.m. at a restaurant in Twentynine Palms to compile the results.

We will meet at 6:30 a.m., at the big ARCO just off of the expressway near Mecca. Dress warmly; it can be cold in the early morning hours. We will form six or seven groups and spread out over the count circle for a day of counting the multitudes of birds that spend the winter around the north end of Salton Sea.

Bird identification skills are helpful but not a prerequisite; the group leaders will handle any identification problems. Counting ability is a prerequisite. Each group leader needs people to count common birds (like Eared Grebes, Ruddy Ducks, American Coots, gulls), and someone to record the numbers, so that he/she can concentrate on finding the unusual and/or hard-to-find species.

If you want a mellow day of birding at Salton Sea, save yourself \$6 and we'll see you in January on the field trip. If you want a rather intense day of birding, and would like to contribute to the ever-growing (since 1969) data bank, come on out. You will see lots of birds. We typically record 130-140 species.

After the count we will compile our results at a local restaurant.

Audubon California establishes endowment to support California State Parks

Emeryville, CA – Audubon California announced today that it has established an endowment that will provide long-term financial assistance to California State Parks to support important conservation, restoration and public outreach projects. The endowment is the latest expression of a longstanding partnership between the two organizations. "Audubon California sees our state parks as a legacy that we all need to support," said Glenn Olson, executive director of Audubon California. The decision to create the endowment stems from Audubon California's long-standing partnership with California State Parks. Following the recent sale to the state of 220 acres of land located on the southern edge of Clear Lake, about 100 miles north of San Francisco, representatives of Audubon California saw the opportunity to create a unique legacy that will fund conservation projects on public lands for years to come. Audubon California's initial contribution to the endowment is \$700,000. The organization has committed to continue to raise funds and contribute to this endowment, which is expected to pay out about 5 percent annually to projects throughout the state park system selected by Audubon through a competitive process involving local Audubon chapters and California State Parks.

With this victory in hand, the Surfrider Foundation is now free to focus on an upcoming hearing by the California Coastal Commission to determine if plans for the SR-241 toll road extension are consistent with California Coastal Act.

Maybe this is the year - Mystic Lake is very low due to the drought. The northern San Jacinto Valley is known for its high species diversity, but who knows this year. We have ranked highest in number of bird species seen for inland areas in North America for Audubon's Christmas Bird Counts, and are usually in the top 1-2% for all counts. At the heart of the region is the public San Jacinto Wildlife Area. This trip at times has been called the "waterfowl trip," the "goose trip," and "a wonderful field-trip." It is all of that, and more. Perhaps a glimpse at last year's list will help stoke the fires of desire: American white pelican, white-faced ibis, snow goose (thousands), Ross' goose (hundreds), surf scoter, white-winged scoter, peregrine falcon, prairie falcon, sandhill crane (hundred), mountain plover (hundred and a half), and gila woodpecker. We tallied twenty species of waterfowl, and we didn't have to count individuals. (For an opportunity to count every single duck on the Sea, see Salton Sea - North CBC blurb elsewhere in this issue.) We will meet at the Wister Unit of the Salton Sea National Wildlife Refuge at 7:00 a.m. Wister is on Highway 111, east side of the Sea, several miles before Niland. The turn-off is Davis Road. We will bird around the southern end of the Sea, then go south into "ag" lands to look for raptors, mountain plovers, and the always entertaining sandhill cranes.

all known to populate the hillsides and creeks. From a habitat preservation standpoint, wilderness corridors are necessary to connect the beach with the foothills and interior mountains via Beach/San Mateo Campground and river drainages and canyon bottoms. Access to a fresh water source is vital for survival, especially during the hot summers. The future of Trestles grows increasingly uncertain. The Trans-They need rough mountains to make their dens and hide away, and open grassy hillsides to hunt and forage.

The Problem: Rancho Mission Viejo (RMV) and the County of Orange have approved a new city for the foothills east of San Juan Capistrano and Ladera Ranch for almost 40,000 new residents and 5 million square feet of commercial/office space. In addition, the Foothill/Eastern Transportation Corridor Agency approved a 16-mile extension of the Foothill South

Nearly 1800 tricolored blackbirds were color-banded during the 2007 breeding season; your assistance in reporting observations of these color-banded birds is essential to help us to learn more about tricolors. All birds were fitted with a USGS aluminum band, a white color band (denoting the year) and an additional color band denoting county (Yolo County = green, Yuba County = blue, Colusa County = orange).

Arnold Schwarzenegger this weekend signed landmark legislation to ban the use of lead ammunition from important habitat areas. Your calls, letters and emails helped make this victory happen. "This is a great day for the California Condor and the State of California," said Glenn Olson, executive director of Audubon California. "This is really an indication of how much of an impact we can have when we all work together for a common goal."

ship with State Parks that will significantly enhance our common goals of protecting wildlife species and habitats across the State," said State Parks' Director Ruth Coleman. "This creative idea of an endowment establishes a new model for assisting State Parks with its land protection and management responsibilities and we welcome this new partnership." The relationship between Audubon and California State Parks goes back to the 1960s when the state was beginning to identify and prioritize the protection of key natural areas for their scenic, natural, historical and recreational potential. Since then, the two organizations have partnered on many conservation and education projects, with Audubon contributing not just funding, but technical support and volunteers as well. "Our state parks not only provide important habitat for birds and other wildlife, they are the places where millions of Californians learn about our natural heritage," said Graham Chisholm, director of conservation for Audubon California. "Audubon California wants to help see them protected and enhanced by bringing Audubon funding and volunteers." California State Parks owns and manages 278 park facilities across California, a total of more than 1.5 million acres, that make up some of the most diverse natural resources found anywhere in the world. As an example of the diversity: Fifty-eight per cent of the remaining old growth coastal redwood forests are found in State Parks; 27 per cent of federally listed endangered, threatened or rare species can be found in the State Park system; there are 71 natural preserves and reserves in the system; the largest desert state park in the nation, Anza-Borrego Desert State Park is within the system; and, more than onequarter of the coastline of California, 295 miles, is within the park system. On average, 77 research projects, primarily related to wildlife habitat, are ongoing each year in the State Park System..

# The 107th California Christmas Bird Counts

December 14th 2006 to January 5th 2007

This holiday season join with thousands of birders who participate each year in the more than 100 Christmas Bird Counts across California. The one day bird counts provide valuable data about the number of bird species and numbers of each species occurring within a set geographic area. Whether you just watch your bird feeder or spend a full day in the field with friends, it a great way to have fun and gather important information on bird populations.

Participants are typically assigned to teams based on their bird identification skill level and endurance. A \$5.00 participation fee defrays a portion of the cost of tabulating and publishing the count results by National Audubon and Cornell Lab of Ornithology. Help is needed on many of these counts, so find one that interests you and contact the compiler for more information.

Bearpaw Ranch is SBVAS's 70 acre nature sanctuary, operated by the San Bernardino Audubon Society and may be visited 7 days a week from dawn 'til dusk by members of Audubon and their guests.
